**Tacit Clause**

This policy is valid for the *policy period* stated in the Schedule or in the latest issued endorsement and shall, at the discretion of the *insurer*, at the end of such *policy period* and each subsequent *policy period*, be automatically renewed for a new period of 12 months; except that either the *policyholder* or the *insurer* may terminate this policy by giving the other party written notice of such termination no later than 30 days prior to the end of the current *policy*

The existing sanctions clause is replaced by the following:

**Sanctions Clause**

The *insurer* shall not be deemed to provide cover and the *insurer* shall not be liable to pay any *claim* or provide any benefit hereunder to the extent that the provision of such cover payment of such *claim* or provision of such benefit would expose the *insurer*, its parent company or its ultimate controlling entity to any sanction prohibition or restriction under United Nations resolutions or the trade or economic sanctions laws or regulations of the European Union Republic of Ireland United Kingdom or United States of America.

All other terms and conditions remain unchanged.
